

In accordance with s. 33(c) of the *Freedom of Information and Protection of Privacy Act*, the *Motor Vehicle Act*, and the Access to Motor Vehicles Information Regulation, the Alberta Registry of Motor Vehicles (the "Registry") collects specific personal information to confirm the identity of the consenting individual, to uniquely identify the consenting individual, and to produce the information product, and to confirm the identity of the recipient and of the authorized employee of the recipient (ที่ต้องการได้รับเอกสารนี้). The information may be used to verify the identity of the individual or organization that has requested the release of the information product. The Registry receives complaints about the release. NOTE: This consent is valid for three months after the consent is dated. The information product released can be faxed by the registry agent only to the Lawyer using PART 2.
